Who can enjoy the Offer

- 2. The Offer is exclusive to an existing customer (Referrer) and the new customer who was referred by the Referrer (New Customer) of Livi Bank Limited (livi or we).
- 3. The Referrer must:
 - a. within the Promotion Period, refer a new customer (New Customer) who successfully applied and drawn the first livi Flexi Loan "Personal Loan" with a designated minimum amount and repayment period; and
