



## Terms and Conditions – livi Business Instalment Loan Cash Rebate Offer

### Promotion Period

1. The Promotion Period for livi Business Instalment Loan Cash Rebate (Offer) is valid from 21 August 2023 to 30 September 2023, both dates inclusive (Promotion Period).

### Who can enjoy the Offer

2. The Offer is exclusive to customers of Livi Bank Limited (livi or we) who have successfully applied and drawn down the livi Business Instalment Loan (Business Instalment Loan) using the invitation code "BIL#OFFER" during the Promotion Period and up to a specified amount (listed below), with a minimum loan tenor of 24 months and have fully settled the first 6 instalments in accordance with the repayment dates agreed or specified by livi (Specified Instalment), and who fulfil other conditions set out in these Terms and Conditions (Eligible Customers).
3. Subject to our approval, Eligible Customers must meet the following criteria:
  - a. a customer who has business operation in Hong Kong for at least one year

### Who cannot enjoy the Offer

4. The Offer is not available to the following customers:
  - a. a customer whose drawdown under the livi Business Instalment Loan does not fulfil the requirement sets out in the Specified Instalment; or
